Observations and Corrective Actions

Violations cited in this report must be corrected within the time frames below, or as stated in sections 8-405.11 and 8-406.11 of the Food Code

8: 5-205.11.(A): N: Hand wash facility not accessible.

INSPECTOR NOTES: Multiple items are blocking the hand wash sink and an employee beverage was stored in the well. Keep area free from any obstructions or anything that gets in the way of proper handwashing. *COS

14: 4-501.114.(A).(1): C: Dishes/utensils are not being sanitized in water with the correct chlorine sanitizer concentration.

INSPECTOR NOTES: Chlorine solution sanitizing certain food contact surfaces, equipment and utensils off the chart, too high. Use test kit to achieve 50-99 ppm for chlorine bleach and a 200-400 ppm for Quat sanitizer.

45: 4-501.11: N: Equipment in disrepair.

INSPECTOR NOTES: The counter top across from the 3 bay sink is severely damaged and subject to rot and absorption of liquids. Replace to be smooth, sealed and easily cleanable. Top cover of ice cream machine is cracked and missing pieces. Replace the cover within 30 days and provide proof to myself via email picture.

46: 4-302.14: N: No chemical test kit available.

INSPECTOR NOTES: **REPEAT Purchase chlorine test strips if chlorine bleach is used. (50-99 ppm concentration)

Following are a few of the major changes: * No Bare Hand Contact with Ready-To-Eat Food. * Establishments must have clean-up procedures for employees to follow following vomiting and diarrheal events. * Date marking of Ready-to-eat potentially hazardous foods.

Violation Correction Timeframe:

Critical violations should be corrected on site, but in any event, within 10 days. The licensee must contact Louis Lachance when the critical violation has been addressed at 207-513-3125 extension 3224 or at llachance@lewistonmaine.gov. Non-critical violations must be corrected within 30 days. Failure to satisfactorily correct these violations before the follow-up inspection may result in enforcement proceedings by the Department to include fines and penalties. License renewals can be denied if violations are not corrected within the noted timeframes.

C= Critical violation and NC= Non-critical violation:

“Critical violation” means a provision of the Food Code that, if in non-compliance, is more likely than other violations to contribute to food contamination, illness or environmental health hazard.


Additional Inspection Fee:

License fees provide for two inspections per year. When additional inspections are required, the Department may charge an additional \$100 fee to cover the costs of each additional inspection or visit.

Document Retention/Posting:

Pursuant to the Maine Food Code, the establishment's current license must be displayed. In addition, a sign or placard must be posted in a conspicuous area notifying consumers that a copy of the most recent inspection report is available upon request. CFPM


